CHROME, GOLD+ AND PLATINUM+ Terms and Conditions | 2025

MEDICAL HEALTH INSURANCE, EMERGENCY EVACUATION, REPATRIATION AND MEDICAL EXPENSE PROGRAMMES

This Agreement provides **Members** with medical and personal services in cases of Acute Illness and/or Bodily Injury, whilst resident or travelling in sub-Saharan Africa or, alternatively, whilst resident in sub-Saharan Africa and for travel worldwide (excluding USA/Canada and South America) or, alternatively, subject to the limitations of each health scheme as set out in the Table of benefits attached at the end of this Agreement.

The following terms, conditions and exclusions shall govern the provision of assistance by **Specialty Emergency Services** to **Members** in terms of the Agreement entered into between **Specialty Emergency Services** and the **Member**, and these terms, conditions and exclusions shall be read with and deemed to be incorporated in the Agreement, which shall apply hereto.

This cover begins on the date indicated on the acceptance letter, no benefits are provided for illnesses that arose before the start of the insurance cover, unless declared and accepted by Specialty Emergency Services.

1. **DEFINITIONS**

For the purposes of this Agreement:

- 1.1 "Specialty Emergency Services" or "SES" refers to Specialty Emergency Services Limited. Registered company number 36581 (PACRA, Zambia). Postal address: Specialty Emergency Services, P. O. Box 30337, Lusaka, Zambia. Physical Address: Plot 335, Cnr. Kafue Road & Mahogany Dr. Lilayi, Lusaka.
- 1.2 **"The Territory"** shall mean the sub-Saharan Continent, south of the 15N latitude.
- 1.3 **"Acute Illness**" shall mean any sudden and unforeseen deterioration of health which is potentially life-threatening and which first declares itself during the Membership Period.
- 1.4 "Agreement" shall mean this Agreement.
- 1.5 **"Application Form"** shall mean the completed application, detailing personal details, updated contact information and medical details and original signature.
- 1.6 **"Assistance**" shall mean the services provided by Specialty Emergency Services and referred to in clause 3 below.
- 1.7 "Bodily Injury" shall mean any accidental, sudden,

unforeseen and severe or violent physical injury which is potentially life-threatening and occurs at an identiable time and place during the Membership Period.

- 1.8 **"Child"** shall mean a person under the age of nineteen (19).
- 1.9 Chrome, Gold+ and Platinum+ shall mean the type of Assistance rendered by Specialty Emergency Services, including emergency medical relocation and/or repatriation and medical expenses (as defined in 3.1) up to maximum limits, as stated in the Table of benefits, per Member, per annum and per membership period.
 - 1.9.1 **Chrome** will extend benefits for Acute Illness or Bodily Injury to South Africa or worldwide (excluding USA/Canada/South America) only.

Medical evacuation to, and hospitalisation in, the closest appropriate facility in South Africa or worldwide (excluding USA/Canada/South America) will also be paid.

Additionally, benefits for elective treatment are extended in South Africa and worldwide (excluding USA/Canada/ South America), with in-country (Zambia) coverage.

1.9.2 Gold+ will extend benefits or Acute Illness or Bodily Injury worldwide (excluding USA/Canada/ South America). Medical evacuation to, and hospitalisation in, the closest appropriate facility worldwide (excluding USA/Canada/South America) will also be paid.

> Additionally, benefits for elective treatment are extended worldwide (excluding USA/Canada/ South America), with in-country (Zambia) coverage.

1.9.3 Platinum+ will extend benefits for Acute Illness or Bodily Injury worldwide (excluding USA/Canada/ South America). Medical evacuation to, and hospitalisation in, the closest appropriate facility worldwide (excluding USA/ Canada/South America) will also be paid.

Additionally, benefits for elective treatment are extended worldwide (excluding USA/Canada/ South America), with in-country (Zambia) coverage.

- 1.10 **"Dependant**" shall mean a child, spouse, parent or any person declared as a Dependant by the Member.
- 1.11 **"Diagnosis Referral**" if a Member requires referral for an illness that is not clearly covered by the de nitions contained in these terms, Specialty Emergency Services may (if requested) arrange a consultation with an appropriate specialist.







- 1.12 **"Subscriptions**" shall mean the amount due and payable by the Member under the terms and conditions of the Agreement with Specialty Emergency Services. Subscriptions will vary and may or may not be determined by the member's claims history.
- 1.13 "Doctor" shall mean a person who:
 - a. is a registered medical practitioner who is duly quali ed and licensed to practice medicine;
 - b. is acting within the scope of their license;
 - c. is not the Member or part of the Member's immediate family.
- 1.14 **"Fare-Paying Passenger**" shall mean a passenger on a commercial aircraft in an economy seat.
- 1.15 **"Force majeure"** shall mean an event which is beyond the reasonable control of a policy holder and which makes the provision of services impossible and shall include wars, invasions, pandemics, acts of foreign enemies, revolutions, riots, civil commotion, rebellion, insurrection or sabotage, explosions, oods, major res, earthquakes or other exceptional natural calamities and exceptional acts of God or any change in law in force in the country.
- 1.16 **"High-Risk Activity"** will mean any situation, activity, or exposure that could be reasonably expected to lead to illness, bodily injury, or is expected to aggravate a prior illness or injury. Any activity for which you require safety equipment, have to sign indemnity for, and require special training may be considered high risk. A high-risk activity usually puts a member at greater risk of injury or death than a member who does not participate in this activity.
- 1.17 "**Life Threatening**" shall mean any Acute Illness or Bodily Injury that is deemed immediately life- or limbthreatening by Specialty Emergency Services.
- 1.18 **"Medical Emergency"** shall mean any incident resulting in bodily Injury or Acute Illness as defined herein, where, in the opinion of Specialty Emergency Services, the Member requires urgent hospitalisation and treatment.
- 1.19 **"Medical Evacuation**" is necessitated by an acute injury or illness that results in the necessary emergency evacuation of the member to the nearest facility where de nitive treatment can be given. An emergency evacuation must be ordered by a licenced physician who certi es that the severity of the injury of illness warrants an emergency evacuation.
- 1.20 **"Member(s)**" shall mean the person(s) named on the Application Form and Notification of Membership, such person(s) having been accepted for membership and having paid the required subscription.
- 1.21 **"Membership Card"** shall mean the membership card which identifies the Member and states the Member s number, names of the Member, type of health plan and expiry date.
- 1.22 "Minor" shall mean a person under the age of 18.
- 1.23 "Personal Risk" shall mean any acitivity or activities

known to involve highrisk of exposing a person to illness or accident, or is expected to aggravate a prior illness or injury.

- 1.24 **"Receiving Physician"** shall mean a Specialist, Medical practitioner or institution receiving a referred member.
- 1.25 "**Relocation**" shall mean transporting the Member from one medical facility to a medical facility deemed more appropriate by Specialty Emergency Services, as the result of a Medical Emergency.
- 1.26 **"Repatriation"** shall mean the return of the Member to their country of residence, following a Medical Emergency.
- 1.27 **"Residence"** shall mean the address and country at which the Member is normally resident within the Territory which is included within the membership card and was provided on application to Specialty Emergency Services. No change in address shall be incorporated within the terms of the Agreement unless Specialty Emergency Services has been noti ed and has agreed in writing.
- 1.28 **"Sporting Activity"** shall include both official organised events and casual, unofficial events or activities.
- 1.29 **"The Parties"** shall mean Specialty Emergency Services and the Member.
- 1.30 **"Urgent Care"** refers to non-life threatening conditions that require prompt treatment but a re typically not of such seriousness as to require immediate emergency care.
- 1.31 **"Worldwide**" shall mean all countries worldwide, excluding USA/Canada/South America.
- 1.32 The headings appearing in this Agreement have been used for reference purposes only and shall not affect its interpretation.
- 1.33 Unless the context clearly indicates the contrary intention:
 - 1.33.1 words in the masculine gender shall include the feminine and vice versa;
 - 1.33.2 the singular shall include the plural and vice versa.

2. DURATION AND APPLICATION

- 2.1 Membership will only be valid for the period specified on the Membership Notification and Membership Card unless the membership is cancelled by either the Member or Specialty Emergency Services during the specified period, whichever occurs first.
- 2.2 Application for membership, including the medical questionnaire of Specialty Emergency Services, on behalf of the Member and/or their family, must be completed in full and signed by the Member or their legal representative.
 - 2.2.1 All particulars so declared are deemed to be certi ed to be correct by the Member s signature or that of their legal representative.







- 2.2.2 In case of false declaration and/or omissions, the Agreement is null and void and all Subscriptions will be forfeited and any claim shall be repudiated.
- 2.3 Minors are not eligible for individual membership.
 - 2.3.1 A Minor may benefits from a guardian and/ or parent's membership upon a parent's acceptance of individual membership and that of a Dependant. An application for any Dependant will require completion of a new application form.
- 2.4 Specialty Emergency Services will not commence cover for a new dependant, whether spouse, partner or child, until the Member's application for that new dependent has been accepted, and until payment of all Subscriptions has been received.
- 2.5 Specialty Emergency Services reserves the right to decline any application, including that of a new dependant, at Specialty Emergency Services' sole discretion and without justi cation.
- 2.6 The Member agrees and undertakes to subscribe for the services provided herein at the subscription fees stipulated on the application form, invoice or quotation and agrees to be bound by the terms, conditions and exclusions hereof.
- 2.7 Upon acceptance by Specialty Emergency Services of the Member's application and receipt of full payment of Subscriptions and issue of a Membership Card & Membership Notification, Specialty Emergency Services undertakes to perform its obligations, including the provision of Assistance as herein de ned, to the Member in the event of Bodily Injury or Acute Illness, subject to the terms, conditions and exclusions contained herein.
- 2.8 Upon receipt of the application from the Member, Specialty Emergency Services shall be entitled to decline such application and its decision shall be nal and binding and Specialty Emergency Services shall not be required to furnish or substantiate its reasons for declining any such application.
- 2.9 The Member undertakes to pay all the Subscriptions on application or by the renewal date.
 - 2.9.1 Failure to comply with this will result in the automatic termination of the Member's medical cover.
 - 2.9.2 This termination will coincide with the initial date of the application or renewal.
 - 2.9.3 Membership expires at midnight, Central African Time, on the last day of the subscription period.
 - 2.9.4 It is not the duty of Specialty Emergency Services to notify the Member of membership expiry.
 - 2.9.5 Reinstatement upon subsequent receipt of the subscription shall warrant reapplication of general exclusions with effect from the date of reinstatement.
- 2.10 No Member will have automatic right to cover with

Specialty Emergency Services. Full medical underwriting will apply.

- 2.11 At each renewal date, Specialty Emergency Services reserves the right to alter or discontinue the benefits, terms, conditions and subscriptions of this medical health plan and will notify the Member, by email or postal address, of such changes prior to the renewal date.
 - 2.11.1 A current Member shall provide a physical address working for the sole purpose of email or receiving notices in the English language.
 - 2.11.2 Notices sent to the provided address shall be deemed as received and acknowledged by the member.
 - 2.11.3 Failure to open any notice and/or mail for whatever reason shall not invalidate the alterations.
 - 2.11.4 A copy of the current terms and conditions is available on the Specialty Emergency Services website, www.ses-unisure.com/health/.
- 2.12 The Specialty Emergency Services price list and loading percentages are a guide only and are in no way binding. Specialty Emergency Services reserves the right to adjust prices for each membership application or renewal.
- 2.13 Renewing members are entitled to request a no-claims discount if no medical claims have been processed in the preceding membership year. The no-claims discount will be applied to the member's current age band. This incentive does not apply if there has been a lapse in membership.
- 2.14. The Specialty Emergency Services reserves the right to decline or accept any request made by a member.

3. MEDICAL SERVICES

The following Services shall be rendered and/or provided by Specialty Emergency Services at its sole discretion, upon the occurrence of a Medical Condition befalling the Member, up to the limits provided for in this Agreement.

All medical services require pre-authorisation.

3.1 Medical Expenses

Specialty Emergency Services undertakes to pay for all approved, reasonable charges for medical treatment, diagnosis and advice provided to the Member provided that:

- 3.1.1 such services were provided during the period of the Membership Agreement;
- 3.1.2 they are in accordance with the terms and conditions of the Membership Agreement;
- 3.1.3 such services were approved and medically necessary; such services were prescribed by and administered by a properly quali ed and licensed doctor;







- 3.1.4 such services were authorised by Specialty Emergency Services;
- 3.1.5 if medical services were provided in South Africa or worldwide, as a result of a medical emergency or non-emergency, such charges will be paid at the SES rates, based on market related rates only, subject to approval by Specialty Emergency Services.

3.2 **Remote Medical Advice**

Should the Member require medical advice or Assistance, they or their representative may telephone the Specialty Emergency Services Call Centre where Specialty Emergency Services medical personnel will advise the Member on the necessary action they should take, depending upon the circumstances as described to Specialty Emergency Services.

- 3.2.1 Such advice may include particulars of the nearest doctor or hospital for consultation or admission.
- 3.2.2 It should be noted that a telephone conversation may not permit accurate diagnosis and this service shall be considered as advisory only.
- 3.2.3 Specialty Emergency Services shall therefore not be liable for any claims arising out of or in connection with the advice rendered by the Call Centre remotely, regardless if it is an individual or corporate application.

3.3 Emergency Medical Referral

Specialty Emergency Services may refer the Member to a doctor or hospital for emergency treatment.

- 3.3.1 Acceptance of a referral by a member relieves Specialty Emergency Services of any liability, responsibility and/or care.
- 3.3.2 Once a member is referred to a receiving physician, Specialty Emergency Services' duty of care ends at the point of referral.
- 3.3.3 No referral must be assumed to be an approval. All services will be approved, subject to terms and conditions.
- 3.4 Emergency Medical Assistance involving Evacuation, Relocation and Repatriation In the event of a Medical Emergency where Specialty Emergency Services considers the medical services available to that member to be inadequate or should the attending doctor, in agreement with Specialty Emergency Services, recommend hospitalisation of a kind not available in the Member's locality, then Specialty Emergency Services will arrange, monitor, supervise and pay for the following services, subject to
 - approval by Specialty Emergency Services:
 - 3.4.1 the Evacuation of the Member to one of the nearest appropriate hospitals; and/or
 - 3.4.2 the Relocation, with or without medical supervision, by any means considered by

Specialty Emergency Services to be suitable (including air ambulance, chartered or commercial ight, or road transport), to a hospital more appropriately equipped for such Bodily Injury or Acute Illness; and/or

3.4.3 the Repatriation, including road ambulance transfers, to and from the airports with necessary medical supervision to an appropriate hospital or other healthcare facility near the Residence of the Member, provided that the Member's medical condition permits such actions.

3.5 Dispatch of a Specialty Emergency Services Medical Practitioner

At the discretion of Specialty Emergency Services and with due regard to the Member's condition and where Repatriation and/or Evacuation is inadvisable, a medical practitioner may be dispatched to make an onsite evaluation of the Member's condition, to determine their suitability for evacuation and to collaborate with the attending doctor and arrange for the Member's eventual Evacuation or Repatriation.

3.6 Repatriation following Emergency Treatment

After the discharge of the Member from the hospital where the Member may have been admitted or transferred, as provided for in these terms and conditions, Specialty Emergency Services will arrange and pay for the return of the Member from the closest International airport, as a fare-paying, seated, economy passenger on a commercial scheduled airline/ ight, to the closest appropriate Airport to their Residence when such return is possible according to the medical opinion of the attending doctor and Specialty Emergency Services.

The choice of airport and the routing will be at the sole discretion of Specialty Emergency Services.

3.6.1 Specialty Emergency Services shall have no obligation in terms hereof where the Member is holding a valid travel ticket as part of the Member's original travel arrangements.

3.7 Appointment of a Local Doctor

If Specialty Emergency Services decides that the Member can be treated in their own locality, then Specialty Emergency Services may appoint a doctor to attend the Member. However, any decision relating to the mode and time of transportation of the Member and whether or not Specialty Emergency Services will provide the same will remain the decision of Specialty Emergency Services.

3.8 Monitoring

Specialty Emergency Services will not be responsible and is not required to keep the Member and/or Members of the Member's family informed of the Member's condition and the type/nature of the Assistance rendered.

3.9 Transport and Accomodation of a Third Party (Chrome and Gold+)

At the discretion of Specialty Emergency Services, while the member is hospitalised, the accommodation costs of one family member of the member in a life- or limb-threatening condition will be paid for by Specialty Emergency Services, up to the maximum







limits as determined in the Table of benefits for up to 30 (thirty) days, to be paid to a registered licensed accommodation provider.

- 3.9.1 Transport and Accomodation of a Third Party (Platinum+) At the discretion of Specialty Emergency Services and where necessary, while the member is hospitalised, the accommodation costs of one family member or colleague of the member in a life- or limb-threatening condition will be paid for by Specialty Emergency Services up to the maximum limits as determined in the Table of benefits for up to 30 (thirty) days, to be paid to a registered licensed accommodation provider.
- 3.10 **Repatriation of Mortal Remains (Chrome and Gold+)** In the event of the Member's death arising from the Medical Emergency or whilst hospitalised outside the country of Residence, Specialty Emergency Services will repatriate the mortal remains by scheduled aircraft or pay for burial or cremation in the country of their death up to an amount equivalent to the repatriation costs that would have been incurred in repatriating the mortal remains.

Mortal remains are repatriated to the member's country of residence only, unless the family and Specialty Emergency Services both agree on a different destination for practical or cost reasons.

3.10.1 Repatriation of Mortal Remains (Platinum+)

in the event of the Member's death arising from the Medical Emergency or whilst hospitalised outside the country of citizenship, Specialty Emergency Services will repatriate the mortal remains by scheduled aircraft or pay for burial or cremation in the country of their death up to an amount equivalent to the repatriation costs that would have been incurred in repatriating the mortal remains.

Mortal remains will be repatriated to the member's country of citizenship unless the family and Specialty Emergency Services both agree on a different destination for practical or cost reasons.

- 3.10.2 The above costs shall not exceed the limits stated in the Table of benefits in respect of any one Member.
- 3.11 Elective Procedures (applicable to Chrome, Gold+ and Platinum+ health plans) Medical or surgical expenses which are not of an emergency or life-threatening nature will be paid under the following terms and conditions:
 - 3.11.1 elective surgery shall mean medical or surgical treatment recommended by a quali ed medical practitioner and necessitated for reasons beyond the control of the Member and that have the potential to become life-threatening;
 - 3.11.2 all elective surgery procedures must be approved in advance by Specialty Emergency Services, at its sole discretion;

- 3.11.3 Elective surgery or treatment for new members will only be eligible for benefits been received, subscriptions have been paid in full and membership has been approved and processed.
- 3.12 Where the Member has pre-approved treatment outside of sub-Saharan Africa under Chrome and Gold+, costs will only be paid to an amount equivalent to the costs if such treatment were provided in South Africa at SES network rates unless a member is subscribed to Platinum+ plans.
 - 3.12.1 Where treatment under Chrome, Gold+ and Platinum+ is required in South Africa or internationally, then Specialty Emergency Services or its agents will make an appointment on behalf of the member within the Service Provider Network, determined at Specialty Emergency Services' sole discretion.
 - 3.12.2 If the member chooses another Service Provider for personal reasons, then the reimbursement provided to that member will be limited to the price the member would have been charged by Specialty Emergency Services' Network Provider. This restriction will apply unless Specialty Emergency Services or its agents are unable to obtain an appointment within a reasonable time frame. This restriction does not apply in the event of an emergency.

3.13 Wellness Benefit

- 3.13.1 Wellness benefit shall mean one full medical examination every two years.
- 3.13.2 A full medical examination would include preapproved costs associated with preventative health checks, which may or may not include: cervical smear test, mammogram, random blood sugar, total cholesterol and lipid pro le and chest -ray for women, or prostate Speci c Antigen test, random blood sugar, total cholesterol and lipid pro le and chest -ray for men.
- 3.13.3 Specific tests will be carried out at a facility of Specialty Emergency Services' choice.
- 3.13.4 Additional tests not listed above are subject to pre-approval and may be charged to the Member.
- 3.13.5 On request of a medical practitioner and with pre-approval by Specialty Emergency Services, bone density tests may be included in the Wellness Benefits for members over 40 (forty) years of age.
- 3.13.6 The Wellness Benefit is available to adult members over the age of 18 (eighteen) only.
- 3.13.7 The limit for Wellness tests and profiles is US \$200 under Chrome within Zambia only at SES Clinics only.







- 3.13.8 The limit for ellness tests and profiles is US 1,000 or equivalent for Gold+.
- 3.13.9 The limit for ellness tests and profiles is US 2,000 or equivalent for Platinum+.
- 3.13.10 The Wellness Benefits does not include preventative investigations speci cally related to hereditary conditions, unless recommended by our SES physician and only after genetic counselling.
- 3.13.11 All Wellness tests to be completed within a seven(7) day period if the same provider is not able to complete the necessary tests on the same day.

3.14 IVF Benefit

IVF stands for in vitro fertilisation. It is one of the more widely known types of assisted reproductive technology. Primary infertility is de ned as the inability of either partner in a long-term relationship to conceive while sexually active, not using a modern contraceptive and pregnancy has not occured.

This benefit is available to Platinum+ members only, under the following terms, conditions and limitations:

- 3.14.1 Treatment is available in South Africa or India only.
- 3.14.2 Waiting period of 8 months applies to new Platinum+ members.
- 3.14.3 Limited to 3 cycles per lifetime and also limited to a monetary value of US\$6,500 per membership year.
- 3.14.4 Eligible members must be aged 39 and below.
- 3.14.5 Pre-approval and medical justification by SES doctors only.
- 3.14.6 Reasonable Specialty Emergency investigations into the Services will pay for causes of infertility. Once the cause is confirmed, Specialty Emergency Services will not pay for anymore investigations in future.
- 3.14.7 This benefits is excluded for members enrolled under Chrome & Gold+.

3.15 Pregnancy and Childbirth Benefits

Pregnancy and childbirth benefits are available to all existing Gold+ and Platinum+ members on a case-bycase basis, subject to approval by Specialty Emergency Services and subject to the monetary and geographical limits as determined in the Table of benefits

3.15.1 Pregnancy and childbirth benefits are not available under Chrome.

- 3.15.2 A member becomes eligible for pregnancy
 - benefits subject to the time limit of 10 (ten) months after enrolment and/or upgrade.
- 3.15.3 At this point, any previous complications of pregnancy, whether deemed significant or not,

will be made available to Specialty Emergency Services at the time of application.

- 3.15.4 Any previous medical history not declared will void all membership benefits and claims. In the event of previous pregnancy complications, the member must subsequently have at least one child without complications to be eligible.
- 3.15.5 Under no circumstance is a member automatically eligible for benefits of any kind, including pregnancy and childbirth benefits.
- 3.15.6 Specialty Emergency Services will not pay for expenses relating to water births or any complications relating to this form of delivery.

3.16 Routine Maternity Care

- 3.16.1 After the pre-determined time limit of 10 (ten) months after enrolment, Specialty Emergency Services will pay the cost of routine childbirth and post-natal treatment and examinations.
- 3.16.2 Ultrasounds during the term of pregnancy are included.
- 3.16.3 Planned caesarean sections are considered routine maternity care.

3.17 Complications of Pregnancy (Gold+ and Platinum+)

- 3.17.1 After the time limit, as determined in the Table of benefits, Specialty Emergency Services will pay for the in-patient treatment necessary as a direct result of a complication as a result of pregnancy.
- 3.17.2 Terms and conditions for routine pregnancy will apply as a standard for complications of pregnancy membership.
- 3.17.3 The combined, total limit for complications of pregnancy for both mother and newborn(s) is as determined in the Table of benefits.

3.18 Routine Newborn Care

- 3.18.1 Newborn care is the treatment received by a newborn from the date of birth and is restricted to the first 7((seven) days of life whilst hospitalised, or up to the monetary limit as determined in the table of benefits
- 3.18.2 Thereafter, no benefits are available to newborns until a completed application and letter from the treating hospital or physician stating the newborn has been discharged as a "well baby" have been submitted and selected membership has been paid for. Normal terms and conditions apply thereafter, which will include exclusions for congenital and hereditary defects.
- 3.18.3 The limit for routine maternity care for both mother and newborn is as determined in the Table of benefits.







- 3.18.4 The limit is the same for a multiple births. This is the maximum amount payable and is regardless of the number of children born.
- 3.18.5 The excess deductible does not apply to this benefits.
- 3.18.6 Repatriation of mortal remains will apply to both mother and child, if applicable, during the specified period of membership.

3.19 Emergency New Born Care

- 3.19.1 Newborn care is the treatment received by a newborn from the date of birth and is restricted to the first 30 (thirty) days of life, or up to the monetary limit as determined in the table of benefits whilst hospitalised only.
- 3.19.2 During the first 30 (thirty) days of life Specialty Emergency Services will pay for all necessary treatment required relating to birth complications, congenital or hereditary defects and abnormalities, up to the limits specified in the Table of Bbenefits.
- 3.19.3 The combined, total limit for complications of pregnancy for both mother and newborn(s) is determined in the Table of benefits.
- 3.19.4 The limit is the same for multiple births. This is the maximum amount payable and is regardless of the number of children born.
- 3.19.5 The excess deductible does not apply to this benefits.
- 3.19.6 Thereafter, no benefits are available to newborns

until a completed application and letter from the treating hospital or physician stating the newborn has been discharged as a "well baby" have been submitted and selected membership has been paid for. Normal terms and conditions apply thereafter, which will include exclusions for congenital and hereditary defects.

3.19.7 Repatriation of mortal remains will apply to both mother and child, if applicable, during the specified period of membership.

3.20 Chronic Wellness Care

The Chronic Wellness Programme is available to all existing Chrome, Gold+ and Platinum+ members on a case-by-case basis, subject to approval by Specialty Emergency Services.

This programme is designed to assist those members who suffer from long term chronic conditions (referred to as chronic patients), such as:

Diabetes;

- Diseases of the Cardiovascular System
- (hypertension, cardiac disease, strokes,
- etc.); • High Cholesterol;
- Gout:
- Asthma/COPD;
- HIV.

Eligible members will be permitted to enrol in the programme as follows:

- 3.20.1 Eligible members will be required to complete a new medical questionnaire;
- 3.20.2 Specialty Emergency Services medical personnel will make contact with the Member who will undergo a speci c medical examination to determine the ef cacy of their medication, as well as determine other potential chronic conditions that may arise;
- 3.20.3 Chronic patients will be required to have regular medical assessments and tests, as arranged by Specialty Emergency Services personnel. The chronic patient's medical condition will be monitored regularly and overseen by Specialty Emergency Services medical personnel;
- 3.20.4 The Specialty Emergency Services Doctor will determine the frequency of visits, up to a maximum of 4 (four) visits per membership year;
- 3.20.5 Where medically necessary, the treatment provided to the chronic patient may be altered to improve the member's prognosis.
- 3.20.6 Chronic medication will be provided up to the benefit limits as determined in the Table of benefits

Should a member elect not to continue with the Chronic Wellness Programme, then they may do so and will consequently lose the benefits of this programme which are:

- 3.20.7 Chronic medication will provided up to the prescription medication limit, as determined in the Table of benefits only.;
- 3.20.8 The member will lose the benefits of specialist attention to their medical condition.

3.21 Dispensing of Chronic Medication

The Specialty Emergency Services Pharmacy will dispense the required chronic medication. If a member chooses an alternative pharmacy, Specialty Emergency Services cannot guarantee that the chronic medication required will be reimbursed in full.

Where a member chooses an alternative pharmacy, the limits associated with the chronic medication benefits will apply. Chronic medication prescriptions will be for three (3) months at a time. If cover expires within the three (3) month period, then medication will be paid up to the cover expiry date.

Members enrolled in the Chronic Wellness Programme will be entitled to the additional limits determined in the Table of benefits for chronic medication for the duration of their Specialty Emergency Services membership. The claims control system will operate as follows:

3.21.1 The Specialty Emergency Services Pharmacy will dispense the required medication after the member has been seen by the Specialty Emergency Services Doctor;







3.21.2 if the required medication is not available locally, the medication will be sourced on a named patient basis only.

Eligibility for the Chronic Wellness Programme will be assessed annually and will be based on attendance with the doctor and/or nurses visits, evidence of lifestyle improvement and disease control.

3.22 Funeral Cash Benefit

Specialty Emergency Services will pay a cash funeral benefits up to the limits determined in the Table of benefits. This benefit carries an additional subscription.

This funeral benefits is available to all registered and paid up members and will be paid on receipt of a claim form and proof of the demise of the member. Payment is made within five (5) working days to an immediate family member.

3.23 Dental Treatment

Specialty Emergency Services will pay for reasonable and customary expenses incurred for dental treatment.

Dental treatment must be provided by a dental practitioner.

Specialty Emergency Services will pay for the following treatment:

- 3.23.1 Preventative treatment such as dental check-ups, x-rays, scaling, polishing and fluoride application.
- 3.23.2 Routine treatment such as fillings, extractions and root canal treatment are included.
- 3.23.3 Major restorative treatment such as crowns, bridges, implants, and orthodontic treatment will be considered.

All dental treatment, regardless of the extent of treatment, is subject to the benefit and geographical limits stated in the Table of benefits.

3.24 Optical Treatment

Specialty Emergency Services will pay for reasonable and customary expenses incurred for optical treatment.

Optical treatment must be provided by an optician, optometrist, or ophthalmologist.

Specialty Emergency Services will pay for the following treatment:

- 3.24.1 One eye test which includes optical consult, sight and vision testing per membership year.
- 3.24.2 Costs for glasses lenses or contact lenses to correct sight and vision problems such as short or long sightedness per membership year.
- 3.24.3 Costs for glasses frames, which must be accompanied by the glasses frames prescription or invoice to support the frames request, every second year of membership.

All optical treatment, regardless of the extent of treatment, is subject to the benefit and geographical limits stated in the Table of benefits.

3.25 Home Nursing

Specialty Emergency Services will pay for home-based nursing for treatment such as anti-biotic therapy, injections or wound dressings by a quali ed nurse, usually following discharge from hospital or on a caseby-case basis, after approval by a Specialty Emergency Services Doctor, up to a maximum of 30 days.

This benefit is not to provide personal assistance, but to provide medical care.

3.26 **Rehabilitation**

Specialty Emergency Services will pay for rehabilitation, including room, board, and therapies; including physical, occupational and speech following discharge from hospital and where a step-down facility has been recommended by the treating physician and approved by a Specialty Emergency Services Doctor. Full clinical details, your diagnosis, treatment plan and possible discharge must be submitted to Specialty Emergency Services for approval prior to rehabilitation admission. Specialty Emergency Services will pay rehabilitation costs in full for thirty (30) days. Thereafter, the member is responsible for these costs.

All rehabilitation treatment, regardless of the extent of treatment, is subject to the benefits and geographical limits stated in the Table of Bbenefits.

3.27 Cancer Treatment

Once cancer is diagnosed, Specialty Emergency Services will pay for medical costs that relate to planning and administering treatment for cancer.

This includes tests, scans, consultations, and drugs (such as chemotherapy, radiotherapy, and cytotoxic drugs).

Advanced therapy medicinal products (these are medicines that are based on genes, tissues or cells that are used for the treatment of disease) will be paid in full for one course of treatment per condition per lifetime under the following circumstances

- 3.27.1 If the member has Gold+ or Platinum+ membership only.
- 3.27.2 If the therapy is administered by a specialist.

3.27.3 If the treatment has been approved for use in the country where you receive it, for the member's condition, stage of disease and stage of treatment.

- 3.27.4 If this treatment has been endorsed by an independent specialist appointed by Specialty Emergency Services.
- 3.27.5 If the treatment is medically appropriate, based on evidence-based medical practice.
- 3.27.6 If the recommended treatment is "best" or "good practice" in national or international evidence-based guidelines.







Specialty Emergency Services will not pay for clinical tests, treatments, equipment, medicines, devices, or procedures that are unproven regarding safety and ef cacy.

All cancer treatment, regardless of the extent of treatment, is subject to the benefit and geographical limits stated in the Table of benefits.

4. DUTIES OF THE MEMBER

The provision of Assistance in terms of this Agreement is governed by the following:

- 4.1 In the case of a Medical Emergency (unless the circumstances are such as to require prior action to be taken) the Member or their representative shall immediately telephone the Specialty Emergency Services Control Centre and shall furnish Specialty Emergency Services' representative with:
 - 4.1.1 their name and address;
 - 4.1.2 their membership number and date of birth;
 - 4.1.3 the name, place, telephone and email where Specialty Emergency Services can reach the member and/or the Member s representative;
 - 4.1.4 a brief description of the Medical Emergency and the nature of the Assistance required;
 - 4.1.5 the Member must get approval from Specialty Emergency Services before commencing any treatment.
- 4.2 Notwithstanding anything to the contrary contained in clause 4.1, where there is a real threat to life, the Member or their representative must endeavour to arrange for the immediate transfer of the Member to a hospital near the place of the incident by the most appropriate and cost-effective and immediate means and shall thereafter notify the Specialty Emergency Services Control Centre.
 - 4.2.1 In the event of an incident resulting in hospitalisation prior to notice having been given to Specialty Emergency Services, the Member or their representative shall contact a Specialty Emergency Services Call Centre as soon as possible and in any circumstances within 48 (forty-eight) hours of the incident, failing which Specialty Emergency Services will not be liable for the costs incurred and treatment provided.
- 4.3 Claims for reimbursement from Specialty Emergency Services for expenses paid and/or incurred by the Member, for which Specialty Emergency Services would normally be responsible in terms of this Agreement or which have been incurred with the consent of Specialty Emergency Services, shall be paid directly by Specialty Emergency Services to the Member, provided such a claim is pre-approved by Specialty Emergency Services and supported by documentary evidence in the form of the medical report, original accounts, invoices, statements and other appropriate or applicable documents.

- 4.3.1 Provided also that the same are received by Specialty Emergency Services within 90 (ninety) days of the occurrence of the Medical Treatment and provided further that Specialty Emergency Services has been informed of the Medical Treatment within 48 (forty-eight) hours immediately following the Medical Emergency as specified above.
- 4.3.2 Specialty Emergency Services reserves the right to verify the authenticity of the documents presented to it and shall withhold reimbursement until verification is completed.
- 4.3.3 Any amount approved and paid to the member shall be paid less the appropriate deductible amount. This deductible amount does not apply to Platinum+.

5. CANCELLATIONS AND UPGRADES

- 5.1 This Agreement may be cancelled by either party subject to a 30 (thirty) days' notice in writing to the other.
 - 5.1.1 In the event of cancellation by Specialty Emergency Services at its sole discretion and depending on the circumstances, a pro-rata return of the Subscription to the Member shall be made by Specialty Emergency Services.
 - 5.1.2 In the event of cancellation by the Member, a pro-rata return of Subscription may be allowed, with a cancellation and administration fee charged, equal to 15% of the total subscription.
 - 5.1.3 Should the cancellation and administration fee be greater than the pro-rata return of annual subscription, the balance will be payable by the member.
 - 5.1.4 No refund will be considered if there are any claims present within the benefits year that the cancellation request is received.
- 5.2 Upgrades will be allowed and processed under the following conditions:
 - 5.2.1 On renewal of membership.
 - 5.2.2 A 90 (ninety)-day waiting period will apply to all international non-emergency claims.

A new application must be completed and underwritten. Exclusions may be placed on the increased coverage area and the increased benefits.

5.2.3 Mid-policy upgrades will not be considered.

5.3 Fraud, Misrepresentation and Abuse

Membership can be cancelled or suspended by Specialty Emergency Services if the member submits false claims and falsi es written information to support such claims. This will also apply to misrepresentation on application or for any claim submitted, as well as abuse of eligible claims. In the event of reasonably demonstrated fraud, abuse or misrepresentation,







Specialty Emergency Services will be authorised to take any necessary steps against such fraud, including recovering the money paid out by Specialty Emergency Services for such fraudulent claims. This will include the right of Specialty Emergency Services to offset any amounts paid toward membership and any pending claims submitted and paid by the member.

6. EXCLUSIONS

Specialty Emergency Services shall be under no obligation to provide assistance to, or pay medical expenses for the Member in respect of:

- 6.1 Hospitalisation and all related costs, including, but not limited to doctors' laboratory, X-ray and imaging fees, medication and medical evacuation costs outside the coverage area as determined in the Table of Benefits.
- 6.2 Such a nature that the Member is nonetheless able to return to their Residence as a sitting passenger in any form of transport, without requiring medical escort.
- 6.3 Resulting directly or indirectly from the intentional and/or deliberate act of the Member, such as self-in icted wilful injury or suicide or any attempt thereat or participation by the Member in any criminal activity.
- 6.4 Attributable directly or indirectly to war, invasion, acts of foreign armies, armed hostility (regardless of there being no formal declaration of war), civil war, rebellion, insurrection, terrorism, riot and civil commotion or as a member of any security force or group engaging in any aforementioned activities.
 - 6.4.1 Evacuation or Repatriation may be considered but is not guaranteed at the discretion of Specialty Emergency Services if a member suffers Bodily Injury as a result of any of the foregoing events provided, they were not actively participating nor had travelled into an area where any of the foregoing events are in progress.
 - 6.4.2 Specialty Emergency Services is not obliged to enter any area in which Specialty Emergency Services paramedics or employees may be placed in any danger or potential harm.
- 6.5 Any illness or medical condition of a mental, psychiatric or nervous nature, irrespective of whether or not treatments or counselling are medically indicated or recommended as a result of an authorised covered procedure or condition.

This exclusion does not apply to Chrome, Gold+ and Platinum+;benefits limits are determined in the Table of benefits Standard terms and conditions and exclusions apply, where applicable.

- 6.6 Where the Member is undergoing medical treatment for a condition which at the time of commencing a journey or if the journey was undertaken against the advice of their attending doctor.
 - 6.6.1 Including following any journey taken with the

intention of obtaining medical treatment unless the Member has received prior approval from Specialty Emergency Services.

- 6.7 Caused while the Memberis engaged in any professional, competitive or frequent recreational sporting or high risk activity, or any activity considered by Specialty Emergency Services in its discretion as being of a dangerous nature, including but not limited to: parachuting; gliding; paragliding; parascending; scuba diving; hang-gliding; bungee jumping; polo; equestrian activities; motor rallying and motor-cycle racing unless agreed, loaded by membership subscription and accepted by Specialty Emergency Services.
 - 6.7.1 Specialty Emergency Services reserves the right to decline cover for speci c periods of time, activities or events even if the sports cover loading is paid and accepted should the risk be deemed excessive by Specialty Emergency Services.

Members are required to follow the accepted norms of safety whilst participating in any sport or activity and failure to do so will void cover.

- 6.7.2 It is the responsibility of the member to assess whether external conditions, e.g. weather, may impact the safety of participation in sports events and activities, and take appropriate action to avoid risks.
- 6.7.3 This exclusion includes whilst the Member is engaging or participating in racing of any kind involving the use of a power-driven vehicle.
- 6.7.4 This exclusion includes whilst the Member is engaging or participating in activities of any kind involving the use of a vessel or aircraft, aeronautics or aviation, except as a fare-paying passenger in a properly licensed and operated aircraft.
- 6.7.5 Specialty Emergency Services may consider granting cover where loading is applied, to a Member who is licensed to y their own (or a) registered aircraft.
- 6.8 Arising in connection either with or as a result of any pre-existing, recurring, continuing or hereditary illness or condition for which the Member has received medical advice, had symptoms (whether investigated or not), had treatment or sought advise prior to the Member's date of entry during the 24 (twenty-four)-month period immediately preceding the date of their application for membership.
 - 6.8.1 However, after 24 (twenty-four) months continuous membership, certain pre-existing or hereditary conditions will/may, at the sole discretion of Specialty Emergency Services, become eligible for benefits (with applicable deductions), provided the Member has not:
 - a. Consulted a medical practitioner or specialist for medical treatment or advice other than in a check-up capacity.







- Altered medication (including drugs, medicines, special diets or injections, alternative medications and/or therapies) for that condition, for a period of 24 (twenty- four) months after the date of entry.
- 6.8.2 Where Specialty Emergency Services believes there may be a connection with a pre-existing, recurring or continuing illness or condition for any claim, the onus is on the Member to prove that no such connection exists.
- 6.8.3 Specialty Emergency Services is not obliged to cover a hereditary illness or condition following the exclusion period.
- 6.9 Chrome does not have any benefits for any pregnancyrelated treatment.
 - 6.9.1 This shall include any complications of labour and treatment up to the discharge from hospital in a healthy condition.
 - 6.9.2 This shall also include terminations on nonmedical grounds.
- 6.10 Treatment related to surrogacy. This exclusion includes the member acting as a surrogate, as well as anyone else acting as a surrogate for the Member.
- 6.11 For the harvesting or storage of stem cells, i.e. ovum, cord blood or sperm storage.
- 6.12 Directly or indirectly caused by, or arising from, or contributed to by nuclear material or by ionising radiation or contamination by radioactivity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel.
 - 6.12.1 For the purpose of this exception only, combustion shall include any self-sustaining process of nuclear ssion.
- 6.13 Caused directly or indirectly as a result of the Member being under the in vence of liquor or drugs, save that, in the case of drugs, this exception shall not apply where such drugs have been prescribed by and taken in accordance with the instructions of a doctor, but not for the treatment of drug abuse or drug addiction.
 - 6.13.1 Specialty Emergency Services reserves the right to insist on tests should the in uence and/or abuse of any substance be suspected.
 - 6.13.2 Refusal to be subjected to a drug test by a member renders the Agreement null and void and all paid subscriptions forfeited to Specialty Emergency Services.
 - 6.13.3 Drug tests are compulsory for any road traffic accident prior to SES accepting the costs for treatment.
- 6.14 Specialty Emergency Services will not pay for treatment for, or arising from, the harmful, hazardous or addictive

use of any substance including alcohol, drugs and medication.

- 6.15 Where treatment is provided after the expiry date of this Agreement.
- 6.16 For treatment in homes for rest cures, sanatoria or custodial periods of guarantine or isolation.
- 6.17 For cosmetic, scar revision or plastic surgery:
 - 6.17.1 Cosmetic or plastic surgery may be necessitated by a Medical Emergency or for remedial purposes as a result of a covered surgical procedure and which has been authorised by Specialty Emergency Services on a case-by-case basis;
 - 6.17.2 This exclusion includes removal of fat or other surplus tissue from any part of the body;
 - 6.17.3 Whether or not for psychological purposes, and any associated treatment costs consequent of such treatment;
 - 6.17.4 For treatment for cryopreservation, implantation or re-implantation of living cells or living tissue, whether autologous or provided by a donor.
- 6.18 For any costs associated with any form of dental treatment exceeding the limits determined in the Table of benefits; except following accident, where all treatment, up to the limits determined in the Table of benefits is pre-approved.
 - 6.18.1 For any costs associated with any form of dental treatment under Chrome.
- 6.19 Resulting from failure of Specialty Emergency Services to carry out the Agreement due to circumstances beyond their control.
- 6.20 Costs relating to medication and treatment for first line HIV treatment as these can be sourced from Government Clinics. Second and third line HIV treatment will be covered up to the benefits limit as dictated in the Table of benefits.
- 6.21 When the nursing treatment is administered by family, relatives of the Member whether qualified or not.
- 6.22 For ICU treatment following 14 (fourteen) days, unless approved by Specialty Emergency Services and following the provision of a medical practitioner report.

6.22.1 Home nursing costs exceeding thirty (30) days.

- 6.23 Rehabilitation costs exceeding 6 (six) weeks.
- 6.24 When such expenses have been incurred after the membership period, or costs that exceed the benefits Limits stated in the Membership notification and/or the Table of benefits.
- 6.25 Investigations, diagnostics and treatment directly or indirectly arising from or connected with male or female birth control, sterilisation, family planning, infertility, hormone imbalances and any form of assisted reproduction. This will include IUD insertion or removal under any circumstance.







- 6.26 For investigations, diagnostics and treatment of impotence or any consequence thereof, treatment for sterilisation or fertilisation, vasectomy or other sexual related conditions or gender reassignment.
- 6.27 Costs for treatments that were not prescribed or recommended by a medical doctor, is medically necessary and/or pre-approved by Specialty Emergency Services, including, but not limited to physiotherapy and chiropractic treatment.
- 6.28 For transportation, including the courier fees associated with the procurement of prescribed medication, devices and medical accessories, unless such travel is required by air or road ambulance in the case of an immediately life-threatening Medical Emergency and pre-approved by Specialty Emergency Services.
- 6.29 Costs incurred for the Member remaining in the country where treated after discharge from hospital or approved nursing home, unless prior agreement has been received from Specialty Emergency Services.
- 6.30 Costs of food, lodging or transportation for a companion and family member, unless included in the Table of benefits for not more than the monetary amounts determined in the Table of benefits up to a maximum time limit determined in the Table of benefits in life- or limb-threatening conditions only. Alcoholic beverages claims will not be refunded.
- 6.31 For treatment provided which is not medically necessary or pre-approved by Specialty Emergency Services.
- 6.32 Costs recoverable under Medical Aid or other insurance.

6.33 Medical expenses for procedures and/or treatment which was offered outside of the geographical limits determined in the Table of benefits for each health plan.

- 6.34 Newborns until 7 (seven) days after discharge from hospital in a healthy condition.
- 6.35 Congenital abnormalities unless determined and accepted by Specialty Emergency Services and where the condition is covered in the Table of benefits.
- 6.36 "Well baby" care and routine immunisations that exceed the limits stated in the Table of benefits.
- 6.37 When a member deliberately avoids medical treatment until such time as a condition becomes lifeor limb-threatening in order to qualify for emergency evacuation benefits.
- 6.38 Costs associated with arti cial life maintenance. This exclusion includes mechanical ventilation where such treatment will not or is not expected to result in the member's recovery or restore the member to their previous state of health.

Specialty Emergency Services will not pay for arti cial life maintenance when the Member is unable to feed or breathe independently and requires percutaneous endoscopic gastrostomy (PEG) or nasal feeding for a period of more than 90 days.

6.39 Costs, in Specialty Emergency Services' reasonable opinion, are associated with experimental or unproven treatment regardless of whether they are medically recommended or prescribed.

- 6.40 Costs associated with transplants involving mechanical or animal donors; the removal of a donor organ from a donor; the removal of an organ from the Member for the purposes of transplantation into another person, as well as the purchase of a donor organ.
- 6.41 Costs for routine examinations, including gynaecological investigations and tests, inoculations, vaccinations at the sole discretion of SES and other preventative medicines.
- 6.42 Costs associated with routine eye tests, correction of eyesight, non-trauma related eye surgery and the provision of visual aids unless provided as a benefit with the benefit limited determined in the Table of benefits.
- 6.43 Costs associated with routine hearing tests and the provision of hearing aids that exceed the limits determined in the Table of benefits.
- 6.44 Costs of providing or thing external prosthesis, corrective devices, appliances, replacement batteries and Dexcom (every three (3) years only), that exceed the limits detailed in the Table of benefits.

Advanced devices will be paid for as a once-off benet. No upgrades or replacements are eligible for refund. Replacement batteries for these devices will be paid for every three (3) years only.

- 6.45 Costs associated with any second or subsequent medical opinions from a medical practitioner or specialist for the same condition.
- 6.46 Care and treatment for learning, physical or developmental dif culties in children, including but not limited to; hyperactivity, attention de cit disorder, educational development and behavioural problems, unless enrolled under Platinum+ and up to the limits detailed in the Table of benefits. The member enrolled under Platinum+ must consult with a recognised Specialist Paediatrician, Registered Education Psychiatrist of a Specialist Paediatric Psychiatrist only.
- 6.47 Costs related to any elective treatment, unless the excess deductible has been paid under Chrome and Gold+, i.e. the specified monetary amount payable by the Member as specified on the Membership notification, in advance, as per the terms and conditions, and approval obtained as per this Agreement.
- 6.48 Costs associated with chronic medication prescriptions that exceed the limits determined in the Table of benefits or, if enrolled on the Chronic Wellness Programme.
- 6.49 Any and all sleep-related breathing disorders. This exclusion includes sleep studies for insomnia, sleep apnoea, sleep medication, sleep aids, snoring, or any other sleep-related disorder.
- 6.50 Costs related to slimming remedies, speci cally any surgery to remove adipose tissue and/or any gastrointestinal procedures or any other medical intervention to achieve weight reduction.
- 6.51 Prescriptions for dietary supplements, natural or herbal







remedies or therapies, even if these remedies have been prescribed by a medical doctor.

- 6.52 Nutrition and dietician referrals under Chrome policies.
 - 6.52.1 Nutrition and dietician consults that exceed the limits stated in the Table of benefits for Gold+ and Platinum.
- 6.53 Traditional medicines and other non-registered medication and therapies.
- 6.54 All additional costs that relate to an increased BMI (Body Mass Index). This will apply if the member's BMI exceeds 30.
- 6.55 Costs associated with travel or education visa applications.
- 6.56 Costs relating to routine, elective or non-emergency orthopaedic surgery in the first twelve (12) months of membership.
- 6.57 Costs relating to routine, elective or non-emergency othopaedic surgery in the first twelve (12) months of membership or after the twelve (12) months of membership if the member has a BMI that exceeds 30.
- 6.58 Costs relating to any fraudulent claims and misrepresentation by the member.
- 6.59 Except as herein provided, Specialty Emergency Services shall not be liable for the provision or non-provision of services and anything incidental to the said services.

7. CONDITIONS

The Member must:

- 7.1 Pay the subscription in advance.
 - 7.1.1 Failure to settle all subscriptions due shall render this Membership Agreement cancelled from inception in respect of that Member and no further benefits shall accrue hereunder.
 - 7.1.2 It is the duty of the Member to ensure that Specialty Emergency Services has receipt of payment, and to provide receipt of payment to Specialty Emergency Services prior to membership taking effect.
- 7.2 Advise Specialty Emergency Services in writing of all circumstances likely to give rise to claims hereunder prior to any costs being incurred.
- 7.3 Repay to Specialty Emergency Services any amounts paid by Specialty Emergency Services to the Member which are outside the benefits allowed hereunder or for which recovery is made from alternative sources. 7.3.1 Any amounts not paid to Specialty Emergency Services within 30 (thirty) days will immediately result in the cancellation of the policy.
- 7.4 Pay the excess stated in the Membership notification. Specialty Emergency Services reserves the right to alter

the excess deductible, which will depend upon the condition for which the Member seeks treatment.

7.5 Advise Specialty Emergency Services in the Membership Application Form of any pre-existing or potential hereditary or congenital illness, injury or condition prior to the commencement of membership.

8. HEALTH INFORMATION

Subject to all applicable privacy laws, the member irrevocably authorises any doctor or other person who may have, or may acquire, any information concerning their health to disclose such information to Specialty Emergency Services, and that this authority shall remain in force for a period of not less than 12 (twelve) months following the expiry date of this Membership Agreement.

8.1 If deemed necessary by Specialty Emergency Services, for both the correct treatment of the member and to comply with the terms and conditions, the Member allows Specialty Emergency Services to screen for narcotics and any/all forms of mind-altering substances by blood test undertaken by a licensed doctor in a licensed medical facility.

9. LIMITATIONS

- 9.1 The Assistance provided by this Agreement may be rendered by and on behalf of Specialty Emergency Services by independent contractors, and Specialty Emergency Services shall not be liable to the Member for loss or damage or Bodily Injury of any nature sustained by the Member as a result of any failure, for any reason, either of Specialty Emergency Services to render Assistance in terms of this Agreement timely or at all, or as a result of the manner in which such Assistance may be rendered by or on behalf of Specialty Emergency Services or from any other cause.
- 9.2 Specialty Emergency Services shall not be liable to the Member for the loss or damage caused or attributable to the negligence, whether gross or otherwise, wrongful acts and/or omissions of any of the doctors, paramedics, nursing staff or other healthcare professionals or other persons who may provide direct or indirect services to the Member in terms of this Agreement.
- Neither Specialty Emergency Services nor any person 9.3 required to render assistance hereunder shall have any liability whatsoever to the Member, their heirs or executors, arising out of the failure to render assistance or any delay in the rendering of such assistance, or in rendering inappropriate assistance where such failure or delay is caused by circumstances including but not limited to; mechanical failure, unavailability of the necessary medical personnel or staff, failure of whatever nature on the part of service providers to Specialty Emergency Services, all equipment including vehicles, communication failure or major adverse weather conditions, strikes, lock-outs, labour disputes or unrest, riot or civil commotion and/or the refusal of government/provincial or local authority to grant or allow the use of its services or facilities or to provide such services or facilities or where local laws or regulations or







functionaries or any other force majeure incidents limit the capacity of Specialty Emergency Services or any other person to render such assistance.

- 9.4 Where the Bodily Injury or illness is attributable to the act or omission of any third party under circumstances entitling the Member to recover damages for such Bodily Injury or illness from such third party, the Member shall be obliged:
 - 9.4.1 To notify Specialty Emergency Services in writing of their intentions to take action for the recovery of such damages from such third party, identifying the third party to Specialty Emergency Services;
 - 9.4.2 To include in their claim all amounts disbursed by Specialty Emergency Services in rendering assistance to the Member in terms of this Agreement, the sum total of which amounts shall be provided by Specialty Emergency Services to the Member for such purpose;
 - 9.4.3 Forth with upon recovering such amounts, to pay same over to Specialty Emergency Services, where applicable.
- 9.5 In the event that the Member does not intend to take action to recover damages from any third party, Specialty Emergency Services shall be entitled, against the delivery of an appropriate indemnity in respect of legal costs, to require the Member to code and assign their rights of action against such a third party to Specialty Emergency Services.
- 9.6 Specialty Emergency Services carries professional indemnity insurance, the details of which are available to the Member on request.

Specialty Emergency Services will not cover any form of medical negligence claim that is not covered by the indemnity insurance.

This also applies to any claim that is repudiated by Specialty Emergency Services' reinsurers for any reason.

- 9.7 Compliance by the Member with the terms and conditions of the Agreement shall be a condition precedent to any entitlement to assistance hereunder.
- 9.8 Under no circumstances do services undertaken by Specialty Emergency Services entitle the Member to reimbursement if they were not claimed from and through Specialty Emergency Services.

10. NOTIFICATION

- 10.1 Any notice to be given to Specialty Emergency Services in terms of this Agreement may be delivered to the Member's Postal or Email address in the English language as stated on the last completed application or renewal form.
- 10.2 The Member must, on 14 (fourteen) days written notice,

advise Specialty Emergency Services of any change to such address, which must be a postal address.

11. **ARBITRATION**

The parties will, in the first instance, make every effort to resolve amicably by direct informal negotiation any dispute of any kind arising between them under or in connection with this Agreement.

- 11.1 The informal negotiations referred to above will be conducted by a joint committee comprising one (1) senior executive of Specialty Emergency Services, the member and a third party, jointly appointed by both parties. The committee will have fifteen (15) days to conclude their negotiations.
- 11.2 If, after fifteen (15) days from the commencement of such informal negotiations, the parties have not succeeded in negotiating a resolution or settlement of the dispute, either party may refer the dispute for determination, by arbitration in accordance with the Arbitration Act No. 19 of 2000. The decision of such an arbitrator will be final and binding upon the parties.
- 11.3 The seat of arbitration will be Lusaka, Zambia.
- 11.4 The Arbitration will be administered by the parties before one (1) arbitrator, who will be appointed by the Chartered Institute of Arbitrators in Zambia.
- 11.5 Nothing in this clause will preclude any party from seeking interim and/or urgent relief from a Court of competent jurisdiction and to this end the parties hereby consent to the jurisdiction of the High Court of Zambia for that purpose only.

12. APPLICABLE LAW

The Parties agree that this Contract shall be governed by the laws and regulations in force in the Republic of Zambia.

13. SUBROGATION

In the event of the Member being covered by any other medical or applicable insurance, then the Member shall be obliged in the rst instance to claim against such insurance and Specialty Emergency Services shall only be liable in respect of such amounts which exceed the cover provided by such insurance and up to the Bene t Limits stated in the Membership Schedule. Any portion of the Member's travel ticket which is unused due to an emergency evacuation or repatriation organised by Specialty Emergency Services shall be surrendered to Specialty Emergency Services as soon as possible to enable Specialty Emergency Services to claim for its account any refund which may be due.

14. AMENDMENT

Specialty Emergency Services may, in its discretion, amend this Agreement at any time by notice addressed to the Member in the English language. Such amendment shall not constitute a notation of the terms hereof. Any such amendment shall be effective and







binding on the Member 10 (ten) days after the dispatch of the notice of the amendment to the Member's postal and/or email address.

15. ENTIRE AGREEMENT CLAUSE

This written Agreement represents the entire understanding of the parties and supersedes all prior understandings, agreements, negotiations and proposals, whether written or oral, formal or informal made between the parties. Any additional writings, implied obligations, terms or conditions, oral or written, electronic or otherwise shall not modify any terms, limitations or exclusions provided in this Agreement.

Each Party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this Agreement. Each Party agrees that it shall have no claim for innocent or negligent misrepresentation based on any statement in this Agreement.

16. FORCE MAJEURE

Any obligation or condition arising from this Agreement which prevents either party from performing whether in whole or in part, shall not be considered as a breach of the Agreement if the said non-performance is caused by an event of force majeure. For purposes of this Agreement, an event shall be considered force majeure if it meets the following conditions:

- 16.1 It has the effect of temporarily or permanently preventing either of the parties from performing its obligations under the Agreement;
- 16.2 It is unforeseeable, unavoidable, an act of God, a pandemic and/or government directions which are beyond the control of the Party which declares force majeure and is not the result of its negligence or omission;
- 16.3 Such circumstances, despite the exercise of reasonable diligence, cannot be or be caused to be prevented, avoided or removed by such party; and
- 16.4 Such event materially adversely affects (in cost and/ or time) the ability of the party to perform its obligations under the contract, and such party has taken all reasonable precautions, due care and reasonable alternative measures in order to avoid the effect of such event on its ability to perform its obligations under the Agreement and to mitigate the consequences thereof.

17. NO REPRESENTATION OR RELIANCE

Each Party acknowledges that:

a. No Party (nor any person acting on its behalf) has made any representation or other inducement to it to enter into this Agreement, except for representations or inducements expressly set out in this Agreement; and b. It does not enter into this Agreement in reliance on any representation or other inducement by or on behalf of the other Party, except for any representation or inducement expressly set out in this Agreement.

18. SEVERABILITY

If an Arbitrator or a Court of competent jurisdiction holds any provision of this Agreement to be invalid, illegal or unenforceable (whether in whole or in part), such provision shall be deemed modi ed to the extent, but only to the extent, of such invalidity, illegality or unenforceability and the remaining provisions of this Agreement shall not be affected thereby.

19. EMERGENCY PROCEDURE (Applies to all health plans)

In the event of a Medical Emergency requiring assistance under this Agreement, contact the nearest Specialty Emergency Services medical base and give the operator, in a clear manner, your name, phone number and location.

- 19.1 This call will be forwarded to Specialty Emergency Services' medical personnel. The patient's name, membership number, date of birth and location must be given.
- 19.2 Where possible, state the nature of the patient's condition, i.e. heart attack, motor vehicle accident, etc.
- 19.3 State whether there is a medical practitioner available able to provide medical information.
- 19.4 Give accurate information of the nearest airstrip, hospital or doctor, if possible.
- 19.5 In the case of a motor vehicle accident, do not move the patient until you are certain that there are no head or spinal injuries, or until medical help arrives.
- 19.6 If possible, have passport details for the patient and accompanying relative available.
- 19.7 If you are away from home, seek help as soon as possible and please inform Specialty Emergency Services within 48 (forty-eight) hours.
- 19.8 All numbers for the various centres are on the back of your membership card.
- 20. ELECTIVE PROCEDURE (Applies to Chrome, Gold+ and Platinum+)
- 20.1 In the event of planned admission on an in-patient basis to a hospital, the following steps should be taken. Payment of any expenses incurred by you is not guaranteed unless the following procedure is followed:
 - 20.1.1 the Member should contact Specialty Emergency Services prior to admission, giving full details of the condition and proposed treatment. A detailed medical report must accompany this application;
 - 20.1.2 Specialty Emergency Services' Medical







Department/s will advise you if they have suf cient information to con rm whether coverage is in place. If not, they will advise you of what additional information is required;

- 20.1.3 If treatment is approved by Specialty Emergency Services, the excess deductible amount must be paid to Specialty Emergency Services in advance;
- 20.1.4 Specialty Emergency Services' Medical Department will make arrangements with the hospital for all eligible invoices to be settled directly;
- 20.1.5 Patients must take the first available appointment offered by Specialty Emergency Services.
- 20.1.6 Patients do not have the right to be admitted to hospital prior to consultation appointments or for convenience in the case of non-emergencies;
- 20.1.7 Patients must contact Specialty Emergency Services for approval of any procedure and book an appointment prior to booking ights or any costs being incurred by either the Member or Specialty Emergency Services;
- 20.1.8 Specialty Emergency Services has the right to change the applicable excess for treatments at each renewal or following 14 (fourteen) days' notice.

- 20.1.9 New excess charges shall come into force following 14 (fourteen) days' notice, regardless of acknowledgement or non-receipt by the Member.
- 20.1.10 Excess amounts are set on a case-by-case basis for each treatment and Member.
- 20.1.11 Specialty Emergency Services is not obliged to disclose reasons for alterations in the excess amounts payable.

If circumstances prevent direct billing, Specialty Emergency Services will inform the Member and all bills should be paid and the originals forwarded to Specialty Emergency Services, together with the medical report and within the time frame (as dictated in Section 4).
